## **Property Tax Statements**

Property tax statements for Steinbach have been mailed and are due September 30, 2021. Tax statements are mailed to the current owners at time of printing. It is the property owners' responsibility to obtain a copy should they have recently purchased a property and not received a tax statement. If you are expecting a tax statement and have not yet received a copy or if your mailing address has changed recently, please contact City Hall at 204.326.9877 or e-mail taxes@steinbach.ca.

## **Payment Options**

- By Mail Mail (cheque or money order) together with the bottom portion of your tax bill (see mailing address above). Please ensure payments are received at City Hall on or before the due date. Make cheque payable to City of Steinbach. Cheques may be post dated to the due date.
- In Person Bring your tax bill and payment to City Hall, 225 Reimer Avenue, between 8am and 4pm, Monday to Friday. If paying by debit, ensure you have set up the necessary limit with your bank. Credit cards are not accepted. Pay early to avoid last minute line-ups.
- 24 Hour Drop Off Drop an envelope containing your payment (cheque or money order) and bottom portion of your tax bill in the mail slot at the City Hall administration entrance facing Reimer Avenue.
- 4. Web Banking The City of Steinbach is registered as an electronic banking payee with Credit Union, Royal Bank, CIBC, TD Canada Trust, BMO, and Scotia Bank. If you subscribe to this service, simply log on to make your electronic payment by the due date. Please be aware of your financial institution's processing time to ensure your payment is received by the City by the due date.

## **Tax Payment Plans**

The City offers TIPP (Tax Installment Payment Plan) or PAP (Pre-Authorized Payments) for the payment of property taxes. TIPP is a payment plan which allows taxpayers to make monthly payments for property taxes. PAP is single annual payment on the due date in September. The City does not charge interest or service fees for these programs. Sign up anytime. 

# Dandelions, Living with a Noxious Weed



To some this plant is a welcomed sight, used to provide that first food for our bees, to make salads and wines,

among other uses. To others however, it is a nuisance and property owners will work diligently to keep their yards free of this seemingly invasive plant. Although we may have different views of the Dandelion we do need to understand that it is still a noxious weed and as provided under the City of Steinbach By-Law 1663 the control of weeds and grasses is as follows:

Noxious plants or designated undesirable plants as defined in The Noxious Weeds Act shall be moved to a height no greater than six (6) inches if located within one hundred (100) feet of a habitable structure or twelve (12) inches if located farther than one hundred (100) feet from a habitable structure.

Although they can be noticeably seen covering large areas of property, we need to be mindful before reporting it. As stated in the by-law, the plant must reach a height of 6 inches or greater. We all know that the Dandelion is a very difficult weed to control but it is one we have to live with. By working together and caring for our lawns the best we can, we can help reduce the spread of this weed within the city. #### **Outdoor Pools**



The City's Pool By-Law is in place to minimize risks to residents, especially children. All pools capable of holding

24 inches of water require a City permit and must be enclosed by a fence. Fences must have a minimum vertical height of five feet and must have no openings larger than 4" through which a child could crawl. Any gates must be self-closing and self-latching and equipped with a lockable latch to prevent unauthorized entry. ## Be Notified in an Emergency

The City of Steinbach has a FREE mass notification service that alerts residents about life threatening emergency situations. Residents can opt-in by entering their contact information and subscribe to notifications that they want based on location. Residents can sign up for this service at steinbachalertnow.ca. The City tests the system twice a year.
